## **Course Description**

## 4 quarter units

This course is designed to introduce students to the field of Business Analysis as defined in the Business Analysis Body of Knowledge (BABOK<sup>®</sup>) and PMI-Business Analysis. This course will provide the foundation for understanding the roles and responsibilities of the Business Analyst in enabling change in an enterprise by defining needs and recommending solutions. This introductory course will immerse students into the fastgrowing field of Business Analysis and the value they add to an organization. This course will explore the Business Analysis Core Concept Model (BACCM) further ensuring that students are equipped to consider the quality, completeness, and value of the solutions implemented based on the Business Analyst's analysis and recommendations.

## **Course Outcomes**

- Explain the role of and typical tasks conducted by a business analyst
- Discuss the value of business analysis when approaching complex business problems
- Use the Business Analysis Core Concept Model (BACCM) to analyze problems and develop solutions
- Summarize the key traits and attitudes needed to be a successful business analyst
- Discuss the similarities and differences between business analysis and project management
- Define Key Industry Terms
- Determine the scope of a given project
- Discuss business analysis knowledge areas and explain the processes within each area
- Explain the various Requirements Types
- Examine the relationship between requirements and design as it relates to the activities performed by a Business Analyst
- Identify key stakeholders and develop stakeholder personas for a given project
- Manage stakeholder expectations using a variety of methods
- Develop an appropriate problem statement for a given project factoring in stakeholder requirements
- Differentiate between and select an appropriate system development methodology for a given project

## **Required Reading**

The narrated presentations and web meetings conducted in this course present an introduction to, and roadmap through, the various topics covered by the course. Important considerations are highlighted, and where there is controversy in the industry over the use of certain tools and techniques, that controversy is discussed. This high-level approach is supplemented with selected reading assignments from the course textbooks:

- The International Institute of Business Analysis Body of Knowledge (IIBA BABOK) Version 3.0
- PMI's Business Analysis for Practitioners: A Practice Guide

The instructor may also post links to specific articles, recommended readings/texts and videos from the internet that discuss certain topics in more detail.

## Web Meetings

To maintain the interaction that is available in an in-person classroom course, the lecture content of this course is delivered via *live, weekly online class sessions called "web meetings."* While attendance is not required, you are **highly encouraged to attend** these meetings when they occur.

• Every Week, Thursday at 5 PM

All of the web meetings will be recorded for later viewing, but most of the web meetings will feature small, interactive group activities that you will likely find both enjoyable and educational, which can't adequately be captured in the recording.

professionals with their own day jobs, and so it may take a few days. If you have a question about an assignment, you may ask for guidance via the Discussion Tool or Canvas Inbox, and your instructor will do their best to answer promptly.

The Due Date for all module assignments is **the Friday of the week** after the Web meeting. See the quarterly course Calendar for reference. Submission by Due Date will allow for instructor feedback and potential for resubmission for better scores.

- *Resubmission Period* There is a grace period for resubmission of eligible assignments of ONE week after the Due Date. After this period submissions will be locked and no further assignments or quizzes will be accepted.
  - Submissions during the resubmission period may NOT qualify for instructor review and resubmission for better scores, and may be subject to a reduction in grade.

At the conclusion of the course, a final examination will be given. This examination will be "open book", and will consist of a series of questions and problems that cover the entire course content. However, it is to be your personal work, so you are on the honor system not to discuss it with others or complete the exam with a partner or group. The final exam is worth 20% of your grade.

There are 10 modules total, and each is jam-packed with content and assignments, quizzes, and activities to complete as this is a 4-unit course. You should expect to spend anywhere from 10-12 hours of work per week in this class.
